## **GUIDANCE FOR PROPOSER AND SECONDER OF A CANDIDATE FOR INITIATION OR JOINING A LODGE UNDER THE UNITED GRAND LODGE OF ENGLAND**

- (1) Yours is a heavy responsibility. The good name of your Lodge – and the Craft – depends on the reputation of its members. Every care should therefore be taken to ensure that a candidate's background is well known and that he is a fit and proper person to be made a Mason.
- (2) Your attention is drawn to the Book of Constitutions, Rules 157 to 166 and also the duties contained in Rule 179, the Summary of the Antient Charges, particularly paragraph 14, and Aims and Relationships of the Craft, particularly paragraph 5. You should also acquaint yourself with Part B of this paper, consisting of a copy of the Declaration a candidate is required to make on the Registration Form and an explanation of it.
- (3) A candidate may well be the son of a member of your Lodge and already well known to you. On the other hand he may only be a business or social acquaintance.
- (4) In either case he may have little or no previous knowledge of Freemasonry except that derived from the popular press and uninformed comment. You should therefore invite him to read Grand Lodge's leaflets and possibly to view its videos etc. He should also be encouraged to visit the Grand Lodge website at: [www.ugle.org.uk](http://www.ugle.org.uk). You must also hand him Part B of this paper.
- (5) It has long been standard practice for a proposer to point out to a candidate the financial obligations required of a Freemason and the need to consider these and the calls Freemasonry may make on his time in the light of his family and other commitments. It is also prudent to draw his attention to the suspicions some people have of Freemasonry and therefore the greater need for members of the Craft to maintain the highest standards of behaviour.
- (6) Overleaf is a list of questions to be answered by the proposer and seconder on the Registration Form. A failure to answer any of the questions truthfully may render you liable to Masonic disciplinary sanction. The answers should be considered by the Lodge Committee, and may subsequently be filed by the Lodge Secretary with the candidate's declaration. If the candidate is unable to make an unqualified Declaration, you must tell the Lodge Secretary, giving him full details, so that he may obtain guidance from the Grand Secretary (through the Metropolitan, Provincial or District Grand Secretary if appropriate). You should carefully explain to the candidate the reasons for the process.

## **GUIDELINES FOR ALL CANDIDATES FOR INITIATION OR JOINING A LODGE UNDER THE UNITED GRAND LODGE OF ENGLAND**

On the reverse of this document is a copy of a section of the Registration Form which you will have to complete before your application for membership of a Lodge under The United Grand Lodge of England can be considered. If your answer to any of the questions is untrue, or becomes untrue before you are made a Mason and you fail to disclose the fact, you may, as a member of the Craft, be liable to Masonic disciplinary sanction.

You may feel that the requirement to divulge all convictions\* by a Court is unreasonably searching and that minor motoring offences, for example, could be ignored.

Certainly isolated cases of speeding or illegal parking would not be a bar to membership and there are other minor infringements of the law which fall into this category, but rather than establish a catalogue of exemptions it has been decided to ask for a full and frank disclosure of all offences. If these are of a minor nature or resulted from youthful indiscretion they are likely to be ignored. And if the offence was of a more serious nature but was committed some time ago and there is evidence that you are now of good character and an exemplary citizen, it will not necessarily be held against you.

It is in your interests as well as in the interests of the Lodge which you are applying to join that no-one is accepted whose past conduct indicates that he cannot be relied upon to live up to the high standards expected of a Mason.

Your Proposer and Second would not be putting you forward if they did not believe that you were a suitable person to become a Mason. They will give you advice if you cannot make the Declaration required in the Registration Form.

\* You are not obliged to disclose convictions which are 'spent' under the Rehabilitation of Offenders Act 1974.

1. My application is entirely voluntary.
2. I understand that my duties as a Freemason would include an overriding duty to obey the laws of any country to which I may be subject.
3. I do not expect, anticipate or seek any preferment or financial benefit as a consequence of my being a member of the Craft.
4. I understand that I may freely declare my membership of the Order on any occasion when I can be seen not thereby to be pursuing any business, professional or personal advantage.
- †5. a. I have never been convicted by a Court of any offence  
b. I have never been the subject of a finding of dishonest or disgraceful conduct  
c. I have never been disciplined by any professional, trade or other tribunal  
d. I am not awaiting the outcome of proceedings against me before a criminal court or a professional, trade or other tribunal  
e. I am not, to the best of my knowledge, the subject of any criminal, professional, trade or other investigation.
- ‡6. I am not and have not been in any way connected with any organisation which is quasi-Masonic, imitative of Masonry, or regarded by the Grand Lodge as irregular or as incompatible with the Craft.
7. I undertake that if any paragraph in this declaration should become untrue or misleading at any time before I am made a Mason, I will inform my proposer and seconder without delay, and agree that by presenting myself at the meeting at which I am to be made a Mason I shall represent that this declaration remains true.

† IF THE CANDIDATE CANNOT MAKE THIS DECLARATION WITHOUT QUALIFICATION, OR IN ANY DOUBT AS TO THE SCOPE OF THIS PARAGRAPH HE MUST CONSULT HIS PROPOSER AND SECONDER BEFORE SIGNING THIS FORM OR OTHERWISE CONTINUING WITH HIS APPLICATION. PARAGRAPH 5 MUST BE AMENDED BY DELETING ANY SUB-PARAGRAPH TO WHICH THE CANDIDATE CANNOT SUBSCRIBE. FULL DETAILS OF ANY CONVICTIONS OR ANY SUCH PROCEEDINGS MUST BE DISCLOSED TO HIS PROPOSER, SECONDER AND SECRETARY OF THE LODGE. THE CERTIFICATE OF THE GRAND SECRETARY CONFIRMING THAT THE MATTERS DISCLOSED DO NOT CONSTITUTE A BAR TO INITIATION MUST THEN BE OBTAINED BEFORE THE CANDIDATE MAY BE PROPOSED IN OPEN LODGE. IF AT ANY TIME BEFORE INITIATION THIS DECLARATION BECOMES UNTRUE OR MISLEADING, A FURTHER CERTIFICATE MUST BE OBTAINED.
